The SE- Sundernagar was informed that the A/A & E/S of 8 Nos. schemes will be accorded upto 10/2014 & the estimate of 2 No. schemes will be sent to E-in-C in 11/2014 for obtain A/A & E/S. The position of online entries in IMIS module on the all prescribed formats was reviewed. There is a huge gap in target and achievement in No. of VWSC members trained during 2014-15 in respect of Sundernagar & Kullu circle. The Principal Secretary (IPH) is concerned about difference in progress as stated in the meeting with the on line entries & directed to complete all the on line entries in time and pro-rata targets in these areas are to be achieved before next meeting and concerned SEs will monitor such entires.

7. NABARD (WSS & Irrigation)

(ii) Submission of DPRs after attending observations raised by NABARD.

There are 18 slow moving projects relating to Mandi Zone as on 31.8.2014. The Engineer-in-Chief (IPH) directed the concerned S.Es to accelerate the pace of work & file the reimbursement claims so as to get these projects out of the slow moving projects before 15.10.2014.

The matter regarding preparation of DPRs of MLA priority schemes for the year 2013-14 & 2014-15 was discussed & after detailed discussions it was decided that the Chief Engineer (MZ) will submit scheme wise time schedule for preparation/submission of DPRs to SE (P&I) I & II by 25.9.2014.

(i) MIP Balh Valley (LB)

The phase-II of the project has been commissioned in March, 2014. The SE Sundernagar informed that testing of distribution system is in progress & the PCR will be submitted by 15.10.2014.

After detailed discussions & reviewing the progress on agenda items, the Principal Secretary (IPH) asked to hand over one complete water supply scheme in each Division to PRIs & one completed irrigation scheme to KVS for operation and maintenance on pilot basis upto 31.12.2014 and submit the outcome. Further he expressed his satisfaction & desired that Chief Engineers should convene Zonal Level monthly meeting with concerned SEs/ EEs to review these items also. It was intimated by SO (IPH-B) that meetings of Adhoc Committee has been fixed for 15th & 16th October, 2014. This time the target is to clear all the Audit Paras/ Inspection Reports prior to year 2007-08. Thus original record and the replies in duplicate may be brought in the above meeting alongwith list of pending paras / IRs upto 2007-08.

The meeting ended with a vote of thanks to and from the Chair and it was reiterated that all must adhere to the time lines fixed to complete the tasks.
