Minutes of the 2nd meeting of the State Level Scheme Sanctioning Committee (SLSSC) for the year 2021-22 held under the Chairmanship of Shri Vikas Labroo (IAS), Secretary (JS) to Govt. of Himachal Pradesh, on 7.2.2022

Officers present as per Annexure-A.

The meeting of the State Level Scheme Sanctioning Committee for implementation of Jal Jeevan Mission was held to consider the proposals of schemes to be taken up under Jal Jeevan Mission.

Engineer-in-Chief (Jal Shakti Vibhag) Himachal Pradesh welcomed the Chairman and members to the meeting. After permission of the Chair, Engineer-in-Chief presented the agenda for the meeting and the item wise discussions and decisions arrived thereof is as under.

> Item No.1: Confirmation of minutes of meeting held on 22-07- 2021.

Engineer-in-Chief informed that the minutes of the meeting held on 22-07-2021 were circulated vide letter dated 31/07/2021 and no comments were received. The minutes of the meeting were confirmed.

- > Item No.2: Innovative proposals for approval under Jal Jeevan Mission.
 - a. The proposals for sustainable service delivery in water supplies in District Mandi and District Kullu, were presented by Er Dharmender Gill, Chief Engineer, Mandi Zone. He appreciated the comments received from DDWS, GoI and agreed that the suggestions would be incorporated as under.
 - b. The buffer storage capacity of the following schemes will be revised and reduced as per designed water requirement:
 - i) WSS Digerh G/O villages in GP Bishladhar Ani Block Distt Kullu (HP)
 - ii) WSS Shamoh Jagerh Goura Gowal in GP Shilli, Lote in Nirmand Block Distt Kullu H.P.
 - iii) WSS Hallan-I in GP Hallan-I and GP Sarsei in Tehsil Kullu Distt. Kullu (HP)
 - iv) WSS Pekhari
 - v) WSS Bharain
 - vi) WSS Kandi Tikker
 - vii) WSS Sumanidhar Thach
 - viii) WSS Kandhi Kalwara
 - ix) WSS Shiva Jhamach



- x) WSS Thana
- xi) WSS Bara Ruhmani
- xii) WSS Badech Bagadhar
- xiii) WSS Kandhidhar Sunas
- c. 5% escalation charges proposed earlier shall be deleted and the cost of the proposals will be reduced in the final estimates.
- d. Consultancy Services of IIT, Mandi shall be obtained for this project, as per requirement.
- e. Zinc Aluminium tanks will be considered as per technical feasibility and financial viability.
- f. Quality aspects of construction of the proposed schemes will be monitored by TPIA.

The following proposals were accordingly approved subject to fulfilling the above requirements:

- i) Source Strengthening of water supplies in 9 blocks of District Mandi, Himachal Pradesh for resilient and sustainable service delivery amounting to Rs: 215.47 crore.
- ii) Source Strengthening of water supplies of District Kullu, Himachal Pradesh for resilient and sustainable service delivery amounting to Rs: 138.10 crore.

It was recommended that additional allocation over and above the allotment of the state be made for taking up these projects.

> Item No.3(a): Revised approval of 7 proposals of District Chamba on account of revised scope.

The proposal for revised approval of 7 water supply schemes of District Chamba was presented by Er Sunil Kanotra, Chief Engineer Dharamshala Zone wherein he highlighted that Chamba being an Aspirational District, is targeted to be saturated in this financial year. The sources considered earlier for these schemes were not sustainable and hence the proposals had to be revised from absolutely new water sources for full requirement after getting them verified by the Source Finding Committee. He intimated that overall cost of these schemes is about Rs.153.84 crore and the earlier approved cost in the previous SLSSCs is about Rs.127.13 crore hence there is an additional liability of about Rs.26.71 crore on these schemes. He also emphasized that this revision is imperative on account of the reasons explained above and the source finding committee has also certified the same.

(2)2. PS1 -1

- Item No.3(b) Revised approval of proposals already approved from the SLSSC proposed by Chief Engineers in compliance to the decisions taken in the SWSM Meeting.
 - A. The proposal for revised approval of 27 water supply schemes of Shimla Zone was presented by Er Anju Sharma, Chief Engineer, Shimla. She highlighted that the water sources considered earlier for these schemes cannot meet the future water requirement of these villages and hence the proposals have been revised from absolutely new water sources for full requirement after getting them verified by the Source Finding Committee. She intimated that overall cost of these schemes is about Rs. 225.36 crore and the earlier approved cost in the previous SLSSCs is about Rs. 300.43 crore, hence there is a saving of about Rs. 75.07 crore on these schemes.
 - B. The proposal for revised approval of 8 water supply schemes of Dharamshala Zone was presented by Er Sunil Kanotra, Chief Engineer Dharamshala Zone wherein he emphasized that the surface water sources considered earlier for these schemes are not sustainable on the long term basis and hence the proposals have been revised from absolutely new ground water sources for full requirement. Source Finding Committee has vetted the same based on hydrological studies conducted. He intimated that overall cost of these schemes is about Rs. 62.49 Crore and the earlier approved cost in the previous SLSSCs is about Rs.63.52 crore, hence there is a saving of about Rs.1.03 crore on these schemes.
 - C. The proposal for revised approval of 5 water supply schemes of Mandi Zone was presented by Er Dharmender Gill Chief Engineer, Mandi Zone. He submitted that the water sources considered earlier for these schemes are not dependable and cannot meet the ultimate water requirement. Hence the proposals have been revised from absolutely new water sources for full requirement after getting them verified from the source finding committee. He however, intimated that overall cost of these schemes is about Rs. 56.85 Crore whereas the earlier approved cost in the previous SLSSCs is about Rs. 61.06 Crore. Hence there is a saving of about Rs. 4.21 crore on these schemes.
 - D. The proposal for revised approval of 14 water supply schemes of Hamirpur Zone was presented by Er. Shyam Kumar Sharma Chief Engineer, Hamirpur Zone wherein he highlighted that the old tubewells considered earlier for these schemes are not yielding sufficient discharge and hence the proposals have been revised by proposing absolutely new tubewells for full requirement from identified sustainable sites based on hydrological studies. Source Finding Committee has also verified the same and certificate to this effect is attached with the proposals. He intimated that overall cost of these schemes is about Rs. 164.70 Crore and the earlier approved cost in the previous SLSSCs is about Rs. 171.56- Crore, hence there is a saving of about Rs. 6.86 crore on these schemes.



It was observed that many of the schemes could not be designed on balance water requirement, as per the strategic implementation plan notified by the State Government due to non-availability of dependable sources. However, the overall cost of the revised proposals was less than the earlier total approved cost in the previous SLSSCs. Cost of some of these schemes was proposed to be met from other sources besides JJM funds but due to non-availability of required funds from other sources, these works could not be taken up. In view of the above it was decided that the overall cost of the proposed schemes being less than the overall cost approved in the previous SLSSCs, the schemes be approved on the revised cost as per the list attached in Annexure A wholly from JJM funds.

As regards the changes in Strategic Plan of State to approve schemes from new sources considering the discharge of old to be zero, it was decided that State may change it as per above approval of SLSSC in respect of 61 schemes which also treat existing source to be zero and tap absolutely new sources for full requirement.

Agenda item No.4: Outsourcing the services in Water Testing Laboratories at Sub-divisional Level:

SLSSC approved to outsource the services in 13 Sub-divisional level laboratories at Rohroo, Tikkar, Salooni, Karsog, Panarsa, Jawali, Dharampur, Swarghat, Nadaun, Kangra, Nirmand, Udaypur, Amb as per proposal put up by Chief Engineer WSSO for deployment of staff @ one Assistant Chemist, Lab Assistant and Data Entry Operator for each lab.
