Minutes of address of Hon'ble Chief Minister of Himachal

Pradesh to the Administrative Secretaries/Heads of

Departments / Managing Directors of Boards and Corporations


held at Shimla on 31-12-2012

At the outset, Principal Secretary (Administrative Reforms) to GoHP, welcomed the Hon'ble Chief Minister, Chief Secretary, Administrative Secretaries, HoDs and MDs of Boards/Corporations and other senior officers present in the meeting.

The Chief Secretary in his opening remarks after congratulating the Hon'ble CM for coming to power in the state stated that the vast experience of the Hon'ble CM in the area of administering the State for the past many years will help in making new policies and programs for the welfare and development of the State.

Hon'ble CM started the address with reminding the officers present in the meeting that the election manifesto of the party has been adopted as the policy document by the government and 100% effort will have to be made by all officers to implement it. Emphasizing the importance of employees he stated that the Government would expect the officers to work freely, fairly and as per Rule of Law and there will be zero tolerance for corruption at all levels, however, it would be ensured that there is no witch hunting. He further stated that being a welfare state interest and welfare of the citizens would be sugreme and the officers

would have to ensure delivery of goods and services to be people efficiently, effectively and without any leakages.

Hon'ble CM told the officers that the atrocities against women/girls will have zero tolerance and the police authorities shall have to ensure registration of FIRs and speedy investigation and trial of accused. The State Government will present its strong views on the subject in the meeting of the Chief Secretaries and Director Generals of Police being held at New Delhi on 4<sup>th</sup> of January. There will be a State Level Committee under the chairmanship of Chief Secretary which will meet quarterly and District Level Committees chaired by District Magistrate which will meet once in a month to review all cases of atrocities and to review action taken by police authorities. The Hon'ble CM directed that there will be at least one lady constable at every police station and *chowki* to increase confidence level of aggrieved women at the time of reaching police stations to lodge complaints.

Hon'ble CM reminded all officers that the grievances of the public shall have to be addressed in time at all levels. He requested all the officers to empathize with the citizens while hearing grievances for clear understanding of the situation. Sensitization of the officers including officers working at grass root level i.e. Patwaries, Panchayats, Police Stations to settle public grievances in time bound manner will have to be

ensured. Use of Information Technology especially e-Governance in redressing public grievances shall be priority of Govt. to reduce paper work. The Hon'ble CM directed that projects should be sent to Govt. of India for funding.

Hon'ble CM said that he has noticed that there is delay in completing some of the Projects sanctioned by Government of India. He asked the Chief Secretary to hold regular meeting with the departments to monitor and complete projects in time bound manner. He announced that there will be a Project Monitoring Unit in the Chief Minister's office to review centrally sponsored projects. Targets of Physical and Financial levels allotted to each department in every quarter of financial year shall have to be achieved. Timely submissions of utililisation certificates and completion certificates which are to be sent to Govt. of India shall have to be ensured. The Hon'ble CM directed that all the Departments will propose projects to be submitted to Govt of India well in time to claim central funds under various schemes and warned that budget lapse will be taken seriously. He directed the Planning Department to monitor budget spending every quarter and put up status to him.

He asked the departments to follow up releases by the Govt. of India by stating that 250 crore of AIBP is due and nearly 200 crore of reimbursement of UGC pay scale is due from MHRD. He directed the

officers to note that all the releases to suppliers should be through RTGS and no drafts should be issued. Similarly all individual benefits being released by the Social Justice Department except pensions should be released through RTGS in the bank account of the beneficiaries.

The Hon'ble CM directed the IT department to make *Lok Mitra Kendras* effective and efficient in delivery of Public Services at door step of the common men by adding more and more services to the benefit of the public and to make these kendras profitable so that these centers become self sustaining and provide employment opportunities to the rural youth.

The Hon'ble CM intimated that during recently held NDC meeting at New Delhi he has requested the Government of India to delegate the powers of forest clearance in major hydel projects at the State level. He asked the Secretary (Forest) to review the pending forest clearance cases every month and to coordinate with concerned departments to remove objections at one go and to provide with documents at one go so that the delay in obtaining forest clearance is reduced.

The Hon'ble CM directed that the major road projects which are already delayed should be completed at the earliest and further directed to

start legal action against defaulting contractors. He asked the Public Works Department to ensure repair of damaged roads on war footing so that inconvenience to public is avoided. He further directed that the Government has promised equal development of all regions of State and funds belonging to one MLA shall not be diverted to other constituencies.

The Hon'ble CM directed that the references from his office to concerned authorities shall have to be given top priority and action shall have to be taken on those directions within 5 days.

The Hon'ble CM directed the Industries Department to come out with the proposal to curb mining mafia in the State and to reduce the exorbitant rates being charged by crusher owners. He directed the Industries Department to make efforts to encourage Micro, Medium and Small industries to the State so that employment opportunities to the local youth could be increased. He asked the Department to ensure that 70% employment is given to Himachali people as per rule and survey should be conducted on the lines to check whether this direction is being implemented by all industries. He reminded the officers that he has raised the issue of according special package to HP at par with North-Eastern States.

The Hon'ble CM directed that the departments shall ensure timely filing of replies in the Court cases so that there are no delays on part of the government. He asked all the Secretaries to appoint nodal officers in their branches for monitoring court cases. Filing of appeals and replies in the Hon'ble Supreme Court and the Hon'ble High Court involving financial implication shall be done only after consultation with Finance Department, he stressed.

He directed the Finance Department to convey opinion on the files which are being referred to them by others within one week so that there is no delay in taking decision.

Hon'ble CM emphasized the need of transparent and responsive police administration. He said in a democratic society, every citizen has a right to privacy which can only be curtailed in accordance with law. He said that the alleged tapping of phone without approval of competent authority tantamounts to violation of the provision of Indian Telegraph Act and rules made thereunder. He said the appropriate action shall be initiated wherever violation of Act/Rules is found in case of phone tapping.

The Hon'ble CM directed that all revenue records should be computerized and report submitted to him.

In the end Hon'ble CM wished all the officers a happy and prosperous 2013.

The meeting ended with vote of thanks to and from the chair.
