1st meeting of the State Level Technical Committee to deliberation upon the technical suggestions received from the officers of the department and the proposals of various Firms/ Companies for registration and approval of their products/ services was held at Jal Shakti Bhawan and through Video Conference

- for the first time unemployed (Bonafide Himachali) Graduate Engineers (other than Civil) and Graduate Architects or Diploma holders in Civil Engineering registered under Class B category, and
- for the first time unemployed (Bonafide Himachali) Diploma holders in Civil Engineering or Architecture registered under Class C category.

- Similarly, Class B contractors have been debarred from participating in the tenders having value less than ₹50.00 lakh.
- However, keeping in view the escalating costs of construction materials and rise in wages, the upper limits for B, C and D Class contractor have been raised to ₹5.00 crore, ₹2.00 crore and ₹50.00 lakh respectively.
