MINUTES OF THE REVIEW MEETING OF IRRIGATION AND PUBLIC HEALTH DEPARTMENT HELD ON 6TH JANUARY, 2016 UNDER THE CHAIRMANSHIP OF HON'BLE CHIEF MINISTER, HIMACHAL PRADESH.

List of participants is as per Annexure-"A".

At the outset, Additional Chief Secretary (IPH) welcomed the Hon'ble Chief Minister, Hon'ble IPH Minister and all other participants and specially thanked Hon'be Chief Minister and Hon'ble I&PH Minister for sparing their valuable time to review the activities of the IPH Department. He briefly outlined the activities of the Department. Thereafter proceedings were started with the permission of the Chair.

Power point presentation was made by the department on its mission, organisation setup, major programmes, works in progress, CM Announcements, CM's Budget Assurances and target/achievements. Following points were discussed:

1. While discussing the CM's Announcements it was directed to the ASC by the Hon'ble Chief Minister that DPR of FIS Kamroo Khorgala to Kuppa in Tehsil Sangla, District-Kinnaur be immediately finalised and submitted for funding. It was also desired that DPR of Rishi-Dogri Scheme in Pooh Valley should also be finalised at the earliest. In the matter of Sewerage Scheme Bro-Jagatkhana in District Kullu, the land acquisition process be completed to avoid any conflict at later stage as the I&PH Department has already awarded the tender. In the matter of LIS Ajroli Tehsil Shillai, District-Sirmour, it was directed that the alternate source for the scheme be explored. ACS to Hon'ble Chief Minister further directed that new water supply scheme from Renuka to

Nahan be completed by December, 2016 and he urged the HPSEB Authorities to provide Transformers/Power connectivity to those schemes which are near in completion on priority. The Chief Engineer (Operations), HPSEB assured that the Electricity Board will provide power connectivity to such schemes in a time bound manner.

- 2. On the issue of rates of drinking water supply in Parwanoo, it was decided that a separate meeting will be called with the UD Department and HIMUDA to sort out the issues.
- 3. Hon'ble Chief Minister expressed his concerns over the recurring incidences of jaundice in Shimla and directed the authorities to undertake precautions in providing clean drinking water to the people. He directed that DPRs for all the remaining towns in the State where Sewerage connectivity has yet not been proposed be prepared on priority by the I&PH Department and Finance Department will provide full financial assistance to prepare the DPRs on priority. He further directed that all the vacant post of Surveyors and JDMs in the IP&H Department be filled up on priority as has been done in the matter of PWD Department. The ACS (Finance) to HP Govt. consented on this issue. The ACS to Hon'ble CM pointed out that in the matter of Pump Operator, the IP&H Department should identify the qualified Beldars who possess minimum educational qualification and should be imparted requisite training through ITIs on the same analogy as was done by the HPSEB.
- 4. While discussing the follow up action on Budget Assurance for 2015-16, the ASC to the Hon'ble CM directed that implementation of e-office

software application on Pilot basis in IPH department be expedited by involving department of Information Technology, H.P. On the issue of completion of Treatment Units in 512 Water Supply Schemes in next three years it was decided that all efforts should be made to complete the treatment units and not just restrict to one third of the total targets during the current financial year and Finance Department will release the funds in case more water treatment plants are constructed than what is proposed for the current financial year by the IPH Department. The Engineer-in-Chief, IPH intimated that the department had issued instructions to make construction of WTP mandatory in all new water supply schemes.

5. On the issue of providing irrigation facilities to the farmers which is one of the main agendas of Congress Party Election Manifesto-2012 it was intimated by the department that the department will achieve the target of providing minor irrigation facilities on 3500 hectares of agricultural land by 31st March, 2016. ACS (IPH) ensured the participants that IPH Department will take CAD activities in the remaining areas of Shahnehar major irrigation project and other medium irrigation projects on priority and intimated the Hon'ble CM that water from MIP Shahnehar is being used by the farmers of that area although pucca channels have not yet been completed in all parts of Command areas. He requested the Hon'ble CM to inaugurate the Shahnehar MIP during his winter Kangra sojourn. The Hon'ble CM directed to take command area

- development activities on war footing. He further directed that medium irrigation project Phina Singh MIP in District Kangra should be completed before the tenure of present Government.
- 6. While discussing the issue of drinking water supply schemes in various towns of the State, Hon'ble CM directed that source level augmentation of various LWSS of Bilaspur District from Koldam should be completed by 15th April, 2016. This will help local people of 32 Panchayats of Sadar, Ghumarwin and Naina Devi Constituencies of the District from suffering during the coming summer season. He further directed that Budsar-Hamirpur Drinking Water Supply Scheme should be completed by the department by 15th December, 2016 and Hamirpur Drinking Water Supply Scheme should be completed by 30th September, 2016. He further gave deadline for completion of Mandi Town Water Supply Scheme to be completed by November, 2017, Kullu water supply scheme to be completed by November, 2017 and Manali water supply scheme to be completed by May, 2018. On the issue of installation of supply of power by the HPSEB, ACS to the Hon'ble CM directed the Director (Operations), HPSEB to provide power to the water supply schemes which are near in completion on priority by reviewing the status of the schemes by holding emergent meeting with their counterparts in the IPH Department.
- 7. ACS (Finance), H.P. Govt. expressed this concerns over the short and delay in releases of Central Share in different schemes and urged the IPH Department to take up the issues seriously with the Ministry of

Water Resources by pursuing the matters at various levels by deputing senior officials of the department otherwise overall funding of the department will get reduced drastically. He cited the examples of Swan River Flood Management Project wherein hardly any funds have been released by the Ministry of Water Resources during the last two years.

8. Hon'ble Chief Minister expressed his concern over the status of proposal regarding preparation of DPR for preventing flooding of Una Town from rain water. It was intimated that the proposal is being scrutinized and shortcomings will be sorted out by Chief Engineer, Hamirpur Zone with the Swan River Channelization Authorities and shall be finalized within two months. The work will be funded and executed by the Swan River Channelization authority.

Meeting ended with vote of thanks proposed by Engineer-in-Chief (IPH) who assured the Hon'ble Chief Minister that the direction issued will be followed by the department in letter and spirit.
