MINUTES OF THE 2nd MEETING OF STATE LEVEL SCHEME SANCTIONING COMMITTEE OF STATE WATER AND SANITATION MISSION FOR THE YEAR 2014-15 HELD UNDER THE CHAIRMANSHIP OF PRINCIPAL SECRETARY (IPH) TO THE GOVT. OF H.P ON 14-11-2014

Chairman welcomed the participants and thereafter the agenda items were taken up for discussion as under:

AGENDA ITEM-1: CONFIRMATION OF MINUTES OF 1st MEETING OF 2014-15 HELD ON 24-7-2014 AND ACTION TAKEN REPORT ON THE DECISION TAKEN IN THE 1st MEETING OF STATE LEVEL SCHEME SANCTIONING COMMITTEE OF SWSM.

The minutes of the 1st meeting of State Level Scheme Sanctioning Committee of State Water & Sanitation Mission held on 4-7-2014 were confirmed. Action taken report in the matter is as under:-

a) REVIEW OF PROGRESS UNDER SWAJALDHARA FOR THE YEAR 2002 TO 2013-14.

It was intimated by the Engineer-in-Chief (IPH) that out of 27 incomplete schemes 21 pertain to District Bilaspur, 3 to Sirmour and 3 to District Solan. The EE cum Member Secretary of DWSM Bilaspur stated that out of 15 incomplete schemes, 3 hand pumps have been installed and UCs will be submitted within 20 days. 5 schemes are disputed therefore the matter will be taken up with Zila Parishad for refund of the amount given for these schemes and there will be closed by 31-12-2014. One hand pump has gone dry UC of which will be submitted within 20 days rest 6 schemes will be completed by 31.03.2015. In respect of District Solan out of 3 schemes, one scheme has been completed, one scheme dropped and one scheme is held up due to court case. In respect of District Sirmour Executive Engineer Paonta has informed that out of 3 schemes, one scheme each pertaining to Nohradhar & Paonta Divisions will be completed by 31-12-2014 and remaining one scheme is under investigation by vigilance department, however remaining part of laying of 9 KM pipeline will be completed by 31.01.2015.

In addition to above Executive Engineers Bilaspur and Chamba informed that 40 pending schemes under Swajaldhara were not approved earlier by SLSSC though these stand approved by the respective DWSM's. The Executive Engineer Bilaspur submitted that these 32 proposals neither cover any NC/PC habitations nor satisfy norms for installation of hand pumps. Moreover these proposals are meant for individual households. Therefore he requested for dropping all these schemes. Similarly Executive Engineer Chamba has intimated that 8 proposals in respect of Chamba district do not cover any NC/PC habitations and has requested to drop these scheme.

The committee decided to drop all these 40 schemes from Swajaldhara Programme and the concerned E.E.-cum-Member Secretary (DWSM) will

intimate the decision to the DWSM in the next meeting under intimation to the committee.

b) ACTION PLAN UNDER COVERAGE OF GOVT. SCHOOLS

Out of 165 schools pending for water connection, 123 stand covered. Remaining 42 schools are proposed to be covered latest by 31.03.2015. It was also decided by the committee that no more schools will be covered by the line department but the Education department will make its own arrangement as per the latest guidelines of G.O.I.

c) APPROVAL OF PROPOSAL FOR COVERAGE OF HABITATIONS UNDER NRDWP FOR THE YEAR 2013-14.

The Chairman expressed his concern over 751 incomplete schemes out of which 117 are more than 3 years old and 59 are more than 5 years old under NRDWP approved from 2008-09 to 2013-14. The Chairman emphasized to complete 59 schemes (more than 5 years) latest by 31.03.2015 and 117 schemes (more than 3 years) should be completed by 31.12.2015. It was also emphasized to start the work on the 84 schemes approved in the 1st meeting of SLSSC held on 4-07-2014 before March 2015 and these should be completed within the stipulated period of 2 year for Gravity Schemes and 3 years for Lift schemes and no relaxation in time frame will be allowed for these schemes.

AGENDA ITEM NO 2: APPROVAL OF PROPOSAL FOR COVERAGE OF HABITATIONS UNDER NRDWP.

During 2014-15 there is a target to cover 2509 habitations and to achieve this target 73 Nos. schemes duly recommended by Zonal Chief Engineers amounting to ₹ 3423.85 Lacs have been received and checked under NRDWP which are as under:-

The committee discussed and approved the 73 proforma estimates. The Circle wise/District wise proposal as per Annexure-B shall be circulated to respective I&PH Circles separately.

AGENDA ITEM-3: ACTION PLAN FOR 2014-15-ACHIEVEMENTS.

Out of 2509 targeted habitations for 2014-15, 1328 habitations have been covered upto October 2014. The committee expressed its satisfaction over the progress.

AGENDA ITEM-4: DETAIL OF GPS AVAILABLE AND STATUS OF DATA ENTRY MADE.

Out of 37779 sources, entries of 27722 sources have been entered and it was decided that rest entries for 10057 sources will be completed by March 2015. The Committee expressed its satisfaction over progress of on line entry of GPS of sources.

FRESH ITEMS

AGENDA ITEM-1: APPROVAL OF THE REVISED PERFORMA ESTIMATE.

The proforma estimate for WSS to PC habitation of census village Banuri Khas GP Banuri Khas Tehsil Palampur District Kangra HP was approved under NRDWP for Rs. 138.84 Lakh in the 1st meeting of SLSSC held on 4.7.2014. But since the population as on 1.4.2014 was updated on NRDWP site the total population has considerably increased from population shown on 1.4.2011 for the year as per the latest updated status of habitation as on 1.4.2011. The population shown i.e 8991 persons instead of earlier population of 6537 persons. Due to increase in population the existing scheme is not capable of handling the present requirements. Keeping in view the same earlier proforma estimate approval needs to be cancelled and revised approval for Rs.358.43 lakh needs to be considered and approved:

AGENDA ITEM-2: **APPOINTMENT OF CONSULTANT FOR PREPARATION OF REF(Request for proposal) OF PILOT PROJECT FOR OPERATION AND MAINTENANCE OF IRRIGATION AND WATER SUPPLY SCHEMES FOR PROMOTION OF AUTOMATION.**

As proposed the committee approved the appointment of Consultant. Further action in the matter shall be taken by the PPP Cell constituted by the State Govt. for PPP vide notification dated 12/11/2014 and funds shall be provided by Director, WSSO.

FRESH ITEMS <WSSO>

Agenda Item No. 1: **Printing of book entitled “Drinking Water in Panchayats” in Hindi**

Approval to print 5000 copies of the books in Hindi through Government Printing Press of Shimla was accorded and, additional copies will be printed for distribution to VWSCs based upon the feedback received from field offices after distribution of these 5000 books.

Agenda Item No.2: **Outsourcing of Operation and Manpower in the laboratories**

It was decided that Consultant (Water Quality) WSSO should furnish a report on the working of departmental laboratories to the Engineer-in-Chief, so that appropriate remedial measures, if required are taken.

Parallel outsourcing of Distt. Level labs being run by departmental personal will not be encouraged and item was dropped.

Agenda Item No.3: **Honorarium for collection of samples and its testing with FTKs at GP level/village level**

It was approved that possibility be explored to engage Asha/Aanganwari Workers for collection of samples, their testing with FTKs and maintenance of test record, who have been imparted such trainings of testing with FTKs and Director WSSO will bring a separate proposal on this issue.

Agenda Item No.4: **Declaration of State Level Laboratory**

The MOU of M/s ECO Lab and consultants (P) Ltd, Mohali was allowed to extended for one year w.r.t. 17-12-2014 to 16-12-2015. However, the status of the work done as per current MOU will be intimated to Principal Secretary (IPH) and Engineer-in-Chief (IPH) by Director (WSSO).

Agenda Item No.5: **Payment to Jalrakshaks**

It was explained by Director WSSO that Jalrakshaks who are presently paid Rs. 1350/- per month through concerned Panchayat Pradhans are deployed on distribution of water from sector storage tank(s). It was decided that payment of 2300 Nos. Jal Rakshaks for the year 2014-15 will continue to be made from funds available with WSSO.

Agenda Item No.6: Increase in the honorarium of Resource Persons invited to deliver lecture at State Training Centre, Mandi

As per proposal, presently the honorarium of Resource Persons invited to deliver lecture at State Training Centre, Mandi is Rs. 200/- per lecture prevailing since 2007 and same was enhanced to Rs. 250/- per lecture. One lecture will be of 50-60 minutes duration and there can be maximum two lectures in one session from a resource person.

Agenda Item No.7: Increase in the salary of Data Operator engaged through NIELIT

It was decided that the issue of increase of monthly emoluments of Data Entry Operator/TSPs will be decided by Department of Information Technology & FD and as such item was dropped.

Agenda Item No.2: Engagement of Consultant (IEC) in various DWSMs

Director WSSO intimated that TOR for engaging consultant IEC in each DWSMs is under preparation and will be sent on Single File to Principal Secretary (IPH) for approval by 30th Nov.2014.

Agenda Item No.3: Approval of rates for training through NGOs/DIETs

It was decided that while deciding the rates , the rates of the active NGOs and KRC, SIRD may also be kept to view. Director WSSO intimated that case for approval of rates will be sent on Single file to the Principal Secretary (IPH) by 15th Dec.2014 after preparing a consolidated proposal.

Agenda Item No.5: Approval of reimbursement of mobile phone charges to Consultants

The committee reiterated that as already decided in the SLSSC Meeting the decision regarding payment for Mobile Phone call charges be implemented by the Director WSSO.

Additional Items (of previous meeting):

Agenda Item No.2: Setting up Sub Divisional Lab

After clarifying the action taken on this item for setting up 8 Sub Divisional labs as approved in last SLSSC meeting. Dr. Dinesh Chand, Additional Advisor (PHE) informed that a handy lab kit has been procured in West Bengal and possibility of using similar Kit in Himachal Pradesh may be examined.

Agenda Item No.3: Central Purchase of UV Spectrophotometer and UV Laminar Air Flow Chamber for Bacteriological Analysis

The committee was of the view that the purchase can only be considered after full justification is furnished. As such the item was dropped.

The meeting ended with vote of thanks from and to the Chair.
