RECRUITMENT AND PROMOTION RULES FOR THE POST OF CHOWKIDAR CLASS-IV (NON-GAZETTED) IN THE DEPARTMENT OF IRRIGATION AND PUBLIC HEALTH HIMACHAL PRADESH.

6 Age for direct Between 18 and 35 years.

Recruitment:

Provided that upper age limit for direct recruits will not be applicable to the candidates already in service of the Government including those who have been appointed on adhoc or on contract basis;

Provided further that if a candidate appointed on adhoc basis and become overage on the date when he was appointed as such, he shall not be eligible for any relaxation in the prescribed age limit by virtue of his such adhoc or contract appointment;

Provided further that under upper age limit is relax able for Scheduled Castes/Scheduled Tribes/Other categories of persons to the extent permissible under the General or special order (s) of the Himachal Pradesh Government;

Provided further that the employee of all the Public Sector Corporations & Autonomous Bodies who happened to be Government servants before absorption in Public Sector Corporation/ Autonomous Bodies at the time of initial constitutions of such Corporations/Autonomous Bodies shall be allowed age concession in direct recruitment as admissible to Government servant. This concession will not, how ever, be admissible to such staff of the Public Sector Corporations/Autonomous Bodies who were/ are subsequently appointed by such Corporation/Autonomous Bodies & who are/were finally absorbed in the service of such

Corporations/Autonomous Bodies after initial constitution of the Public Sector Corporations/Autonomous Bodies.

- 1. Age limit for direct recruitment will be reckoned on the first day of the year in which the post (s) is /are advertised for inviting applications or notified to the Employment Exchanges as the case may be.
- 2. Age and experience in the case of direct recruitment is relax able at the discretion of the Himachal Pradesh, Public Service Commission in case the candidate is otherwise well qualified.
- 7. Minimum educational and other qualifications required for direct recruits:
- (a) Essential
 Should be a primary pass from a recognized School/ Institution.
- (b) <u>Desirable qualifications</u>
 Knowledge of customs manners and dialects of Himachal Pradesh and Suitability for appointment in the peculiar Conditions prevailing in the Pradesh.

8. Whether age and educational qualifications prescribed for direct recruits will apply in the case of the promotees:

Not applicable.

9. Period of probation, if any:

- Two years subject to such further extension for a period not exceeding one year as may be ordered by the competent authority in special circumstances and reasons to be recorded in writing.
- 10. Method of recruitment, whether by direct recruitment or by promotion, deputation, transfer and the percentage of vacancies to be filled in by various methods:
- 100 % by appointment from amongst the Work-charged staff failing which by direct recruitment.

Charged staff with 5 years regular service as Work-Charged who are working on analogous posts/categories from Circle Level offices at Shimla and Dharamshala in case of Engineer-in-Chief Office Shimla and Chief Engineer (North) Dharmsala respectively.

12. If a Departmental promotion committee exists, what is its Composition:

As may be constituted by the Govt.. from time to time.

13. Circumstances under which the H.P.P.S.C. is to be consulted in making recruitment:

As required under the Law.

14. Essential requirement for direct recruitment:

A candidate for appointment to any service or post must be:-

- (a) A Citizen of India, or
- (b) a subject of Nepal, or
- © a subject of Bhutan, or
- (d) a Tibetan refugee who came over to India before the 1st January, 1962 with intention of permanently settling in India.
- (e) a person of Indian original who has migrated from Pakistan, Burma, Sri-Lanka, East African Countries of Kenya, Uganda, the United Republic of Tanzania (Formerly Tanzanyika and Zanzibar), Zambia, Malwa, Zaire and Ethopia with the intension of permanently settling in India.

Provided that a candidate belonging to categories (b),(c),(d) and (e) shall be a person in whose favour a certificate of eligibility has been issued by the Govt. of India.

17. Powers to Relax:

may be admitted to an examination or interview conducted by the Himachal Pradesh, Public Service Commission or other recruiting authority, but the offer of appointment may be given only after the necessary eligibility certificate has been issued to him by the Government of India.

Section for appointment to the post in. the case of direct recruitment shall be made on the basis of Viva-voca test, if Himachal Pradesh Public Service Commission or other recruiting authority as the case may be, so consider necessary or expedient by a written test or practical test, the standard/syllabus etc. of which, will be determined by the Commission/other recruiting authority as the case may be.

The appointment to the service shall be subject to orders regarding reservation in the service for Scheduled Castes /Scheduled Tribes / Backward Classes / Other Categories of Persons issued by the Himachal Pradesh Government from time to time.

Were the State Government is of the opinion that it is necessary or expedient to do so, it may, by order for reasons to be recorded in writing and in consultation with H..P P.S.C., relax any of the provisions of these rules with respect to any class or category of persons or posts.
