NOTIFICATION

4. Nurpur and Jawall civil Sub Divisions of Distt. Kangra.

It is notified for the information of the all public as required under Section 5 of the Himachal Pradesh Ground Water (Regulation & Control of Development and Management) Act, 2005 that all officers and officials of the Ground Water Authority is hereby authorized to act upon for the development and regulate the management and control of ground water in these areas.

3. As required under sub section (5) of Section 5 of the Act, the persons who are likely to be affected from this notification, may raise their objections or suggestions to the State Government within thirty days from the date of publication of the notification in the Gazette.


