It is alleged in charge-sheet that in the tenure of previous Govt., Hand Pumps were installed without keeping in mind whether drinkable water is coming out or otherwise. Parameter/ criteria were not followed to install the Hand pumps, due to which the money spent in the schemes goes in vein.

Similarly, one thousand crore Rupees were spent on the equipments, viz.. Pipes, ranch, 2. valve etc. in order to purchase ranch, valve etc. Jalandhar based firms were preferred /favoured by the previous Govt.

It is therefore, requested that relevant record in the matter may be sent to this office, so that further action could be taken accordingly.
