PROCEEDINGS OF THE MEETING HELD ON 13.09.2013 AT 5PM IN HP SECRETARIAT UNDER THE CHAIRMANSHIP OF ADDITIONAL CHIEF SECRETARY (IPH) TO THE GOVT. OF H.P. REGARDING COMPUTERISATION IN IPH DEPARTMENT.

The second meeting regarding computerization in IPH Department was held under the Chairmanship of Addl.Chief Secretary (IPH) to the Govt. of H.P. It was attended by the officials from NIC, IT and IPH departments. The List of participants is attached as Annexure-A. The NIC State unit made a presentation on various modules of MIS prepared specifically for IPH Department and the changes suggested by the Department since the last meeting held in June, 2013.

Following issues came up for discussions during the Presentation:

It was reported by Dr. Saurabh Gupta SIO, NIC that under e-iph, 25 reports are available regarding Monthly Account and out of these 8 reports are OK and changes were suggested w.r.t 17 reports by the IPH Department and out of these 17, 9 have been completed. It was also reported by him that the Department has proposed 15 new reports and out of these 5 have been prepared and work is in progress in case of other reports. Screens developed for monthly accounts were also displayed. The abstract of status in respect of progress made in operationalisation of various modules since 15-06-2013 is depicted as Annex-B.

1) It was decided that the NIC will complete the preparation of all reports as per requirement of the IPH department in close co-ordination with them with in one month and the software will be uploaded for testing immediately thereafter.

2) Since, the funds required for hiring the manpower (3 programmers) have been released by the IPH Department to NICSI as decided during the last meeting; NIC will ensure that the Programmers are in place by 30th September, 2013.

Sensitization workshop for the officers of the IPH department has been scheduled for 25th September, 2013 at Jal Bhavan and all Nodal Officers of the Department shall also take part in the workshop. Such workshops shall be organized for each zone in future and a Calendar for this shall be prepared and shared with NIC with in a week by the IPH Department.

approached for Technical Support Persons (TSP) and the representative of DOEACC ensured that, the staff will be in place with in next 10 days. One TSP shall also be provided to the IPH-A section. It was decided that NIC will provide orientation training to TSPs immediately on their engagement and Nodal Officer will co-ordinate this activity.

4) Android based application to be used for MB entry by JEs was also displayed by the NIC and it was decided that it will be tested and its usefulness will be reported

with in next ten days.

5) It was reported by the officers of the IPH Department that HIMSWAN was not functioning properly for the last one month in the Jal Bhavan and, Joint Director IT was directed by the Chairman to rectify the fault immediately. He also directed the IT department to ensure that e-dispatch is functional at both ends and the Module regarding Energy Bills is in place with in a week positively. Nodal Officer IPH department will take action in this regard.

6) It was also decided that the PMIS related entries will be made at the AD office level by IPH-A section for AEs and above from the existing records by 30th September, 2013, and, simultaneously, for all categories by the IPH department.
