Provided further that if a candidate appointed on adhoc basis had become overage on the date when he was appointed as such he shall not be eligible for any relaxation in the prescribed age limit by virtue of his such adhoc or contract appointment.

Provided further that upper age limit is relax able for Scheduled Castes/Scheduled Tribes/Other categories of persons to the extent permissible under the general or special order(s) of the Himachal Pradesh. Provided further that the employees of all the Public Sector Corporation and Autonomous Bodies who happened to be Government Servants before absorption in Public Sector Corporations/Autonomous Bodies at the time of initial constitutions of such Corporation/Autonomous Bodies shall be allowed age concession in direct recruitment as admissible to Government servants. This concession will not, however, be admissible to such staff of the Public Sector Corporation/Autonomous Bodies who were/are subsequently appointed by such Corporation/Autonomous Bodies and who are/were finally absorbed in the service of such Corporation/Autonomous Bodies after initial consultation of the Public Sector Corporation/Autonomous Bodies.

Age limit for direct recruitment will be reckoned on first date of the year in which the post(s) is/are advertised for inviting applications or notified to Employment Exchanges or as the case may be.

By promotion from amongst the work charged Helpers/Pump Attendant who passes 8 years regular service as work charged which shall include 5 years Experience of working with Pump Motors and Electrical Accessories.

As may be constituted by the Government from time to time.

A candidate for appointment to direct any service or post must be:-

- a) A citizen of India, or
- b) a subject of Nepal, or
- c) a subject of Bhutan, or
- a Tibetan refugee who come over to India before the Ist January,1962 with the intension of permanently

settling in India. e) a person of India origin who has migrated from Pakistan, Burma, Srilanka, East African Countries of Kenya, Uganda, the United Republic of Tanazania (Formerly Tenzanvika, Zanzibar), Zambia, Malwa, Zaire, Ethopia with the intention of permanently settling in India. Providing that a candidate belonging to categories (b), (c), (d) and (e) shall be a person in whose favour a certificate of eligibility has been issued by the Government of India. A candidate in whose case a certificate of eligibility is necessary may be admitted to an examination or interview conduct by the recruiting authority, but the offer of appointment may be given only after the necessary eligibility certificate to has been issued to him by the Government of India. 14. Reservation: The appointment to the service shall be subject to orders regarding reservations in the service for Schedule Castes/ Scheduled Tribes/Backward Classis/ Other categories of persons issued by the Himachal Pradesh Government from time to time. 15. Selection for appointment to Selection for appointment to post by direct recruitment: the post in the case of direct recruitment shall be made on the basis of a general standard as determined by the Recruiting Authority. 16. Power to relax: Where the State Government is of the opinion that is it necessary or expedient to do so, it may, by order for reasons to be recorded in writing relax any of the provisions of these Rules with respect to any class or category of persons or posts.
