

Subject: Guidelines for installation of hand pump on 75 percent costs.

Rationale

Hon'ble Chief Minister of Himachal Pradesh announced during the budget session that hand pumps to individual beneficiaries shall be installed on 75 percent costs. The 75 percent cost shall be paid by the beneficiary and balance 25 percent shall be paid the department. The 75 percent costs shall be paid by the beneficiary in advance in the prescribed mode to the concerned Executive Engineer (IPH) division after ascertaining it's fulfilling the following conditions and hydro geological investigations by the department.

The following norms are hereby fixed for installation of hand pumps by the IPH Department in the state to individual / beneficiary group?

- 1. The estimate for installation of hand pump shall be got prepared through the department. 75% of the total estimated cost for installation of hand pump shall be borne by the beneficiary and balance 25% shall be borne by the department.
- Priority should be given to the places where there is no potable water source/ tail end of schemes and there is scarcity of water due to topographical constraints and erratic water supply.
- 3. No hand pump shall be installed in such locations where it has already reached maximum saturation level.
- No hand pump shall be installed for beneficiaries where their home is on the National highway/ State highway.
- The habitations have been provided road connectivity during the last two years shall be given priority by promoting off road installation of hand pumps.
- 6. As per site conditions the hand pump can be installed by individuals / beneficiary group.
- 7. Energization is not allowed on any hand pump.
- 8. Hand pump should not be located at places near: unlined drains, latrine pits, big trees, at a safe distance from the septic tank, below electric lines and preferably be installed at an elevated area where water logging & flooding does not occur.
- 9. Area should be easily approachable by the user in all seasons.

- 10. The land should be free from all kind of disputes/ encumbrances.
- 11. In case of joint ownership, NOC of other shareholders should be taken on an affidavit.
- 12. The location should be approachable for drilling machine or alternatively the beneficiary shall facilitate C/o such approach for transportation of rig and related men/ material/ equipments at his cost & risk.
- 13. Enough space should be available for construction of a platform and adequate drainage.
- 14. The final site selection for installation of hand pumps would be decided by the Hydrogeologist (of IPH) after carrying out scientific investigations for drilling bore-well point by considering the geological formation and aquifer systems.
- 15. In the event a bore well during the course of drilling comes out to be dry, IPH deptt, shall not be liable for any damages/ consequences arising thereof and the cost involved has to be borne in the same proportion i.e. 75%:25% by the individual / beneficiary group and the department respectively.
- 16. The individual / beneficiary group has to sign on M.O.U. with the department to abide by the terms and conditions as stated above.
- 17. The daily and periodic maintenance of the installed hand pump shall be carried out by the individual / beneficiary group on his own.
- 18. Individual / beneficiary group will be responsible for maintaining the surroundings of the hand pump to ensure potability of water and shall get water sample tests conducted from time to time from the deptt. Labs/ other labs in the area in his own interest. In the event of a water test result shows water not fit for human consumption, the same shall not be used for drinking purpose and shall be painted red along with an indication plate displaying that water of hand pump is not fit for human consumption.

MEMORANDUM OF UNDERSTANDING (MOU) FOR INSTALLATION OF HAND PUMP AT 75% COST BETWEEN INDIVIDUAL / BENEFICIARY GROUP AND EXECUTIVE ENGINEER 1&PH DIVISION.

- Hand pump shall be installed after depositing 75 percent costs of the hand pump in advance by way of treasury challan/demand draft etc.
- The scheme is applicable to all the residents of Himachal Pradesh, who are
 of the age of 18 years or more at the time of filing of application form.
- It is necessary to submit a copy of the Aadhar card, Bonafide Himachali certificate while filling the application form.
- Individual / beneficiary group shall be responsible for providing land for installation of hand pump. The place where a hand pump will be installed, the individual / beneficiary group shall be held responsible for any dispute over that land.
- It shall be the responsibility of the individual / beneficiary group for allowing physical inspection and ensuring cleanliness of hand pump and its surrounding area.
- It shall be the responsibility of the individual / beneficiary group to provide information in respect of the hand pump as and when required by the govt.
- Clear cut title of land is necessary. In case of joint ownership NOC of other shareholders is to be taken on an affidavit.
- If the land located is away from the road then individual / beneficiary group shall provide the road access for the installation vehicles.
 - Individual / beneficiary group shall get the water sample tested and shall
 have to conduct the monthly water testing of the water from water test kits
 made available in Panchayat and a record of the same is to be maintained.

- In case of a negative test report of water sample of a particular hand pump through field testing kit by the individual / beneficiary group, the water sample will be sent to departmental laboratories for confirmatory test / results, for which nothing would be charged by the department.
- The individual / beneficiary group shall be responsible for all kind of minor and major repairs and cost of minor and major repairs shall be borne by the individual / beneficiary group.
- IPH Department shall provide a list of authorized suppliers / rate contact holders of the spare parts to the individual / beneficiary group.
- IPH Department reserves the right to enter into premises and inspect the hand pump at any time for checking purposes.
- Operation and maintenance of all kinds are to be carried out by the individual / beneficiary group.
