
Subject: 1. Scheme wise detail of K. No. & Energy charges
2. Operation of scheme during night hour(10 PM to 6 AM)

1. As already intimated through e-mail as well as on Digital IPH (whatsapp Group) this information was sought to be uploaded on departmental website by all the Executive Engineer's, but till date only details of 5163 connections have been uploaded through google sheet. All these details were discussed today in the weekly review meeting wherein it was observed that most of the K. Nos. are not correct and monthly average bill uploaded for these 5163 connection is also Rs. 158 crore which appears to be on very higher side hence may be verified / reviewed. In this regard it is advised to convene a meeting of all concerned by Superintending Engineer's at circle level and correct information be uploaded on google sheet for discussion in the next weekly review meeting. Information may also be cross verified from concerned HPSEB authorities. It was also observed that 12 Divisions (**As per Annxure "A"**) have not even started the process of uploading the desired information which should be done immediately. (Information uploaded in google sheet is being e-mailed for reference.)

2. In addition to above issues of lifting water during night hours (10 Pm to 6 AM) was also discussed and it was pointed out that due to less manpower & location of most of pump houses in remote area, it is not possible to operate all the schemes in night hours. After detailed discussion it was decided that such scheme which can be easily operated


during night hours be identified and such information be provided with details comments for discussion in next meeting. This matter may also be taken up in the circle level meeting.

Since, a committee has already been ^{constituted} under chairmanship of Chief Engineer (MZ) for remote operation and maintenance of irrigation and water supply schemes with simple automation, it was decided that the committee should also explore ^{to examine} the possibility of operating scheme at night hours through automation in respect of Mandi Zone and submit its findings .
