


Out of above 20 Nos. renewal cases,8 No. (mentioned at Sr.No.1 and 13 to 18 & 20) were found eligible for renewal and remaining 12 Nos.(mentioned at Sr.No. 2 to 12 & 19) were not found eligible due to non fulfillment of work done criteria as per rules.

In view of above **out of total =48 No.**renewal cases under Class-A&B as detailed above, **only 12 Nos.** cases were found eligible as per work done eligibility/criteria as per new IPH enlistment rules-2013 and approved by the enlistment committee in the meeting and decided to issue the renewal orders in favour of approved contractors/firms for next/balance/remaining period and remaining **36 Nos.** renewal cases were not found eligible due to non fulfillment of work done criteria as per new enlistment rules-2013 and not approved by the committee and decided that the matter of un-approved renewal cases of the contractors/firms be taken up with higher authorities so that the un-approved cases could be decided. The committee also decided that the proceedings of the meeting be up-loaded on the departmental web-site and letters for un-approved cases of contractors/firms also be issued.
