The Water Support Sanitation Organization in the process of developing State specific information, Education and Communication strategy and its implementation for reform initiatives in water and sanitation sector for the capacity development of functionaries at all levels. Applications on prescribed format are invited by Director (WSSO) for filling one post of Consultant WQM&S (Water Quality Monitoring & Surveillance) on contract basis for a period one year (likely to be extended by another year). The headquarter of the Consultant will be at Shimla i.e. & his duties will extend to whole of the State. The remuneration/compensation will be paid @ 20000/- fixed per month. TA/DA will be paid as admissible to Grade-II Officers of Himachal Pradesh Government as per Himachal Pradesh TA Rules.

Deliverables expected from the Consultant:

- Assist to develop guidelines, manuals, technical notes etc. on various issues related to water quality monitoring and surveillance aspect of the Rural Drinking Water Supply Programme;
- Liaise with key Resource Institutions at the State Level dealing with Water Quality Monitoring issues Under RWS Programme;
- Collect, analyze, disseminate various successful models on WQM&S and Jalmani programmes and Water sustainability;
- Provide support to State Referral Institute (SRI) in assessment of the performance/capacity of district/subdivision water testing laboratories and suggest improvements;
- Ensure adoption of the Uniform Protocol on Water Quality Monitoring 2005;
- Assist to organize review meetings, seminars, workshops on Water Quality and Sustainability aspect of RW; prepare base papers and final reports;
- Arrange training programmes, induction and refresher, for lab technicians, Engineers and field level workers on Water Quality Monitoring & Surveillance (WQM&S);
- To ensure supply of Field Test Kits/ Bacteriological Kits to all Gram Panchayats and refill every year;
- Ensure regular data updation and online reporting of all Water Quality Monitoring & Surveillance (WQM&S) Parameters;
- To work in close liaison with hydrogeologist of the State to understand ground water quality in different areas;
- Visit districts to monitor the functioning of district level water testing laboratory;
- Prepare quarterly progress reports for discussions and review;
- Undertake any other assignment as directed by Director (WSSO)

- Post - Graduate Degree in Environmental Engineering/Environmental Chemistry/Analytical Chemistry/Geo Chemistry /Microbiology with at least 3 years experience in the field of Water Quality Monitoring & Surveillance. A doctorate in the above field is preferred.
