NOTIFICATION

The Governor, Himachal Pradesh, in exercise of powers vested in him under Rule-15 A of Himachal Pradesh, Irrigation and Public Health, Department, Assistant Engineer (Civil), Class-I (Gazetted) Recruitment and Promotion Rules, 2010 and on the recommendations of HP Public Service Commission, is pleased to order the appointment of following candidates as Assistant Engineer (Civil) on contract basis for a period of one year on fixed contractual emolument of Rs. 21,000/- per month (Minimum of the pay band+ Grade pay i.e. 15600-39100+5400 Grade pay) with immediate effect, in the public interest:-

2 The appointment to the post of Assistant Engineer(Civil) in the Irrigation and Public Health Department is subject to the following terms and conditions:-

- (a) Candidate selected for appointment on contract basis will be initially appointed for one year which shall be extended further subject to satisfaction of work, conduct and performance of such appointee. The service of contract appointee will be purely on temporary basis. The appointment is liable to be terminated in case the performance/conduct of contract appointee is not found satisfactory.



- (b) Contract appointee so selected under these rules will not have any right to claim regularization or permanent absorption in the Government job.
- (c) Contractual Assistant Engineer (Civil) will be entitled for one days's casual leave after putting one month service. However, the contract appointee will also be entitled for 10 days Medical Leave & 5 days' special leave. He shall not be entitled for Medical reimbursement and LTC etc. No leave of other kind except above is admissible to the contract appointee.


Provided that the un-availed Casual Leave and Medical Leave can be accumulated upto the Calendar year and will not be carried forwarded for the next Calendar year.

- (d) Unauthorized absence from the duty without the approval of the Controlling Officer shall automatically lead to the termination of the contract. However, in exceptional cases where the circumstances for un-authorized absence from duty were beyond his control on medical grounds, such period shall not be excluded while considering his case for regularization but the incumbent shall have to intimate the controlling authority in this regard well in time. However, the contract appointee shall not be entitled for contract amount for this period of absence from duty:

Provided that he shall submit the certificate of illness/fitness issued by the Medical Officer, as per prevailing instructions of the Government.

- (e) Contract appointee who has completed three years tenure at one place of posting will be eligible for transfer on need based basis, where ever required on administration grounds.
- (f) Contract appointee will be entitled to TA/DA, if required to go on tour in connection with his/her official duty at the same rate as applicable to regular counterpart officers at the minimum of pay scale.
- (g) Provisions of service Rules like FR, SR, Leave rules, GPF Rules, Pension rules and Conduct rules etc. as are applicable in case of regular employee will not be applicable in case of contract appointee.
- (h) The Employees Group Insurance Scheme as well as EPF/GPF will not be applicable to the contract appointee.
