15. Selection for appointment to post by direct recruitment:

Pakistan, Burma, Srilanka, East African Countries of Kenya, Uganda, the United Republic of Tanazania (Formerly Tenzanvika, Zanzibar, Zambia, Malwa, Zaire, Ethopia with the intention of permanently settling in India).

Provided that a candidate belonging to categories (b), (c), (d) and (e) shall be a person in whose favour a certificate of eligible has been issued by the Government of India.

A candidate in whose case a certificate of eligibility is necessary may be admitted to an examination or interview conduct by the recruiting authority, but the offer of appointment may be given only after the necessary eligibility certificate to has been issued to him by the Government of India.

The appointment to the service shall be subject to orders regarding reservations in the service for Schedule Castes/Scheduled Tribes/ Backward Classis / Other categories of persons issued by Himachal Pradesh the Government from time to time.

Selection for appointment to the post in the case of direct recruitment shall be made on the basis of a general standard as determined by the Recruiting Authority.

16. Power to relax:
