Kindly refer to this office letter No:-IPH-ES-III- JEs. Apptt. Cont. Vol. - XXIX/2016-137-dated:-06.04.2016 on the subject cited above.

In this connection, it is submitted that approval of the Govt. for filling up 70 posts of Junior Engineer (Civil) on contract basis have been received and the requisition for filling up these posts have already been sent to all recruiting agencies, but it will take some time to fill up these vacant posts through recruiting agencies. It is further submitted that vide above referred letter the approval of the Govt. for filling up balance 91 No. posts of Junior Engineer (Civil) by direct recruitment on contract basis was sought, but the approval is still awaited. The work of Irrigation, Water Supply & Sewerage and STP's is suffering badly due to shortage of Junior Engineers (Civil) as the Junior Engineers are grass root functionary in the department.

In view of position narrated above, it is submitted that out of above 91 No. posts, approval of the Govt. for filling up atleast 50 No. posts from amongst retired Junior Engineers (Civil) of this department by way of re-employment is required for a short period of time, till the new recruitments are made, so that the work of this department may not suffer due to shortage of Junior Engineers.

It is therefore, requested that the matter may kindly be examined at the Govt. level and necessary sanction/approval for filling up above 50 No. posts by way of reemployment alongwith its terms & conditions may kindly be arranged and conveyed to this office at the earliest please.
