
Before accepting the joining report of the above officials their original 3 years Diploma in Civil Engineering certificates issued by the concerned authority and Matriculation certificates may be verified by the Superintending Engineer / Executive Engineer concerned himself. In case any one of the above promotee does

not fulfil the requisite qualification, their promotion orders are not to be implemented and the case may be referred back to this office for further orders.

In addition to above their VCC in respect of Circle /Division may also be verified before relieving them to join at higher post, if there is any case pending at Circle/Division level then they should not be relieved and matter be reported to this office with full details.


That in the event of their not joining the post within the fortnight, offer of promotion shall be deemed automatically withdrawn without notice and opportunity and next person in the line shall be promoted. If a person forgoes his promotion then he will be considered for promotion after one year or whenever the post is available, whichever is later. In above category (i) of Surveyors only Sr.No:- 1, 9, 11,13, 14, 15, 17, 18, 19, 20, 22, 23, 24, 25, 26, 27, 28, & 31 and in above category (iii) of the Work Inspectors only Sr.No.2, 3, 4, 5, 6, 7, 8, 9, 10, & 11 are entitled for usual TTA / Joining time as admissible under the rules.

The relieving /joining of above officials may be intimated to this office and all concerned.
