I am directed to refer to the subject cited above and to say that for bringing transparency and to monitor the progress of all the schemes of IPH Department it has been decided to issue A/A and E/S of the schemes through software at all levels i.e. Administrative Department, Engineer-in-Chief, Chief Engineers and Superintending Engineers, as per delegation of powers, through e-iph module henceforth as per procedure given below:

- a) At the initial level i.e. at XEN level, when a proposal for granting A/A and E/S is initiated, the first step will be to fill up every 'field' regarding details of Scheme & Description of Budgetary provisions.
- b) The Screen Shot of the details so filled may be taken and attached with the proposal.
- c) The name of concerned scheme may be checked properly while translating it the same from the List of Works (Appendices of Budget Book) in English and,

as required to be shown in A/A & E/S. This is very important as the 'fields' once filled at the level of initiating office/division will be treated final.

- 2. The above procedure may be brought to the notice of all concerned for strict compliance and Nodal Officers appointed in the Department at Circle level shall coordinate and monitor this practice. No proposal shall be entertained without requisite data and no fresh A/A and E/S shall be issued manually w.e.f. 1st November 2013.
