Further the following terms and conditions are also prescribed in this regards: -

- 1. All the connections except Rural Domestic Connection shall be metered.
- 2. The charges for sewerage connection in Urban & Rural areas (where sewerage facility is available) be levied @ 30% of Water Charges.
- 3. Where in urban areas, some establishments use their own water sources and the sewerage system of the department, sewerage charges be levied @ Rs. 25 /-per seat per month.

- 4. ULBs / PRIs/ VWSC/Outsource Agency can be provided incentive of the total revenue collection on account of water charges as under:
 - a) For collection>75% to 100%, incentive @ 15%
 - b) For collection> 50% but < 75% incentive @ 10%
 - c) If collection less than 50%, incentive @ 5%
- 5. The following categories shall be provided water connections free of cost and consumption charges will also not be levied subject to submission of requisite certificate issued by competent authority: -

Widows, orphans, deserted women, Divyang.

6. Families with annual income less than Rs. 50,000/- will be charged @50% of the notified rates.
