ORDER

WHEREAS, Sh. Alankrit Prakash, Assistant Engineer (Civil) was transferred from Jal Shakti Sub Division, Shat under Division, Kullu District Kullu to Jal Shakti Sub Division, Haripurdhara under Division, Nohradhar District Sirmour against vacant post vide this Department Notification of even number dated 28<sup>th</sup> September, 2022.

AND WHEREAS, Sh. Alankrit Prakash, Assistant Engineer had filed Civil Writ Petition No.6961/2022 titled as Alankrit Prakash V/s State of H.P. & Ors. against his transfer orders and the said Civil Writ Petition was listed on 30.09.2022 and the impugned transfer order dated 28.09.2022 has been stayed by the Hon'ble High Court of H.P.

AND WHEREAS, the said Civil Writ Petition was again listed before the Hon'ble High Court of H.P. on 13<sup>th</sup> March, 2024 and the Hon'ble High Court has disposed of the Civil Writ Petition with the observation that the petitioner shall be at liberty to make a representation to the competent Authority for his adjustment at a place, other than, Nohradhar, District Sirmour and till the competent Authority passes an appropriate order on the said representation, the petitioner shall be permitted to serve at Shat. Such representation shall definitely be made by the petitioner within a period of two weeks from today and in case he fails to file any such representation within a period of two weeks, then the protection extended to the petitioner by the Court about his stay shall cease automatically. Till the representation of the petitioner is decided by the competent Authority, the petitioner shall be permitted to continue to serve as Assistant Engineer at Shat under Kullu Division District Kullu. Pending miscellaneous applications, if any, also stand disposed of.

AND WHEREAS, in compliance to the orders passed by the Hon'ble High Court, the petitioner has made a representation vide which he has requested for his transfer/adjustment against one to the following Sub Division(s):-



- i) Jal Shakti Sub Division, Kullu under Division, Kullu.
- ii) Jal Shakti Sub Division, Shamshi under Division, Kullu.
- iii) Jal Shakti Sub Division, Katrain under Division, Katrain.

AND WHEREAS, the representation of the petitioner was examined and it has been found that the choice of stations given by the petitioner are not presently lying vacant as the incumbent posted in the said stations are having short stay and cannot be transferred in view of imposition of Model Code of Conduct for Parliamentary Lok Sabha Election-2024 in the State.

AND WHEREAS, in view of the inforcement of Model Code of Conduct the petitioner can only be adjusted against any vacant post in and around Mandi District. At present one post of Assistant Engineer (Civil) at Jal Shakti Circle, Sundernagar District Mandi is lying vacant and he can be adjusted at Jal Shakti Circle, Sundernagar District Mandi.

NOW THEREFORE, in pursuant to the order passed by the Hon'ble High Court of Himachal Pradesh, Sh. Alankrit Prakash, Assistant Engineer (Civil) is hereby posted at Jal Shakti Circle, Sundernagar District Mandi against vacant post.
