
WHEREAS, Shri Rajesh Kumar Sharma, Superintending Engineer temporarily posted at Project Management Unit (PMU), Mandi was transferred to Jal Shakti Zone, Shimla vice Shri Vijay Kashyap, Superintending Engineer and Shri Vijay Kashyap, Superintending Engineer was further posted as SE(Works) O/o ENC, JSV Shimla against vacant post vide this Department's notification of even number dated 15th March, 2024.

AND WHEREAS, Shri Rajesh kumar Sharma, Superintending Engineer represented to this Department through Engineer-in-Chief (Project) on 16th March, 2024 to cancel his transfer orders by citing some reasons and requested to retain him at PMU Mandi.

AND WHEREAS, the request of the officer was examined and not acceded to and the ENC, JSV Shimla was requested to direct the officer to join at JSV Zone, Shimla immediately vide this Department's letter of even number dated 18th April, 2024. The copy of the same was endorsed to ENC (Project) JSV Mandi and to the concerned officer as well.

AND WHEREAS, it has come to the notice that Shri Rajesh Kumar Sharma, Superintending Engineer has neither relinquished the charge of the PMU Mandi nor joined at JSV Zone, Shimla even after a lapse of 03 months and despite various directions. It appears that the officer is making mockery of the orders of the superior offices. This action on the part of the officer shows indiscipline and disobedience of the Government orders, which is in contravention of Rule (3) of CCS (Conduct) Rules, 1964 and is liable to unbecoming of a Government servant.

NOW THEREFORE, Shri Rajesh Kumar Sharma, Superintending Engineer is hereby directed to join at his new place of assignment within two days and also explain the reasons for not joining well in time. In case, the officer does not join at his new place of posting within two days, disciplinary action shall be taken against him without any further notice.
