

**Minutes of 46th meeting of Sub-Committee, Himachal Pradesh Ground Water Authority, to process the applications received for grant of permit for sinking of borewell under section 7 & Certificate of Registration of existing users of ground water under Section 8 of Himachal Pradesh Ground Water (Regulation and Control of Development and Management) Amendment Act, 2022, held under the Chairmanship of Member Secretary, HPGWA-cum-Superintending Engineer, P&I-II on 15.05.2023**

The meeting was convened under the Chairmanship of Er. Hemant Tanwar, Member Secretary HPGWA-cum-Superintending Engineer, P&I-II, Jal Shakti Vibhag, Jal Shakti Bhawan, Shimla-5. The following members were present:-

At the outset, Member Secretary Himachal Pradesh Ground Water Authority welcomed all the members of the committee.

The Member Secretary Himachal Pradesh Ground Water Authority apprised the committee that **the Himachal Pradesh Ground Water (Regulation and Control of Development and Management) Amendment Act, 2022** came into force in the State of HP w.e.f 28.03.2023 vide Govt. Notification dated 27.03.2023. Under section 2 (o) of Amendment Act, 2022 the following categories are now exempted for seeking permit for drilling of new borewell:

**"Individual Domestic Consumer", "Rural Drinking Water Supply Scheme", "Armed Forces and Central Armed Police Establishments", "Agricultural Activities", and, "Micro and Small Enterprises drawing ground water less than 10 cubic meter per day",**

**However, after drilling of borewell, the borewell is required to be registered under section 8 of Amendment Act, 2022 for which no fee is required to be paid.**

The Member Secretary (HPGWA) further apprised the members of the committee that-

Also, 3 applications have been received for enhancement of the quantity of ground water extraction from existing borewells, 3 applications for name change and 3 applications for registration of drilling machinery.

During scrutiny, in respect of 4 applications ( Industrial purpose) for certificate of registration wherein the Ground Water Extraction Structure had been installed after the Notification of Notified Areas under Section 5 of the Himachal Pradesh Ground Water Act, 2005 it was decided by the Sub-committee in its 36<sup>th</sup> meeting held on 02.08.2021 that such cases may be approved subject to the action/compounding for ground water extraction structure for Industrial/Commercial purpose under section 22 of Himachal Pradesh Ground Water Act and a compensation of Rs.5000/- as per Rule 32 of Himachal Pradesh Ground Water Rules, 2007 should be levied However, the ground water extraction structures for domestic purpose cannot be imposed any penalty in view of Section 2 (o) of the Himachal Pradesh Ground Water Act, 2005, which states as under:

“User of ground water” means a person or an institution including a company or an industry or an establishment, whether Govt. or not, who or which uses ground Water for any purpose excluding domestic use.

In 42<sup>nd</sup> sub-committee meeting, it was decided that the firms drawing 100 KL/day or above in over-exploited, critical & semi-critical areas and in safe areas the industries and infrastructure projects drawing ground water >500 m<sup>3</sup>/day in hard rock type aquifer and >2000 m<sup>3</sup>/day in soft rock/alluvium type aquifer shall have to mandatorily submit Impact Assessment Report prepared by accredited consultants in consultation with Sr. Hydrogeologist, GWO, JSV, Una.

The Regional Director, CGWB, NHR, Dharamshala was of the view that since **Himachal Pradesh Ground Water (Regulation and Control of Development and Management) Amendment Act, 2022 has come into force in the State of HP w.e.f 28.03.2023**, therefore no permit is required to be issued for drilling of new borewell for the above mentioned exempted categories under section 2(o) of the said Act. However, the Certificate of Registration under section 8 of the said Act may be issued to the applicants and the compounding/compensation for ground water extraction structure only for Industrial/Commercial purpose of Rs.5000/- as per Rule 32 of Himachal Pradesh Ground Water Rules, 2007 should be levied However, the ground water extraction structures for **Individual Domestic Consumer**", "**Rural Drinking Water Supply Scheme**", "**Armed Forces and Central Armed Police Establishments**", "**Agricultural Activities**", and, "**Micro and Small Enterprises drawing ground water less than 10 cubic meter per day**", cannot be imposed any penalty in view of Section 2 (o) of the Himachal Pradesh Ground Water Amendment Act, 2022, Thereafter, the agenda items were taken up for discussion as under:-

The application has been processed. However, since the Himachal Pradesh Ground Water (Regulation and Control of Development and Management) Amendment Act, 2022 has come into force in the State of HP w.e.f 28.03.2023 vide Govt. Notification dated 27.03.2023 & following categories under section 2 (o) of the said Act have been exempted from seeking permit for drilling of new borewell:

6. **National Highways Authority of India, Village Pujarli PO. Beolia Tehsil Shimla Distt. Shimla (HP) 171013 (Submission ID- 45122)**

The applicant has applied on **Form – 1A** for grant of permit for sinking of borewell for **Commercial Purpose**. As per the report of Sr. Hydrogeologist, G.W.O., JSV, Una, **There are 3 departmental energized borewell & one natural source (Babdi) 500 & 300 mtrs away from the site of the applicant. The site is located in highly dissected structural hills comprising of slate, shale, sandstone and limestone of Manjir formation.**

The application was forwarded to the Senior Hydrogeologist & Executive Engineer concerned for site inspection/verification as per uploaded documents and for floating the public notice {Form-2 rule 17 (1) / Form-5 rule 23 (1)} in the offices of concerned Gram Panchayat or Urban Local Authority having jurisdiction, Executive Engineer, Assistant Engineer and Junior Engineer and in case of Industrial/commercial use also for Publication in two leading newspapers, so that interested persons, if any, may file their objection/suggestions. No objection has been received.

**The Sub-Committee has considered the case and the applicant is requested to change the site for not fulfilling the minimum distance criteria as per Section 7(5)(f) of the Himachal Pradesh Ground Water Amendment Act, 2022.**

Therefore, as per the unanimous decision taken by the Sub-Committee, the concerned Executive Engineer (Division No-I Kasumpti) is directed to convey the decision of Sub-Committee to the firm/applicant.

7. **Vikram Katoch S/O Uttam Chand Katoch, VPO Sullah Teh Palampur Distt. Kangra HP (Submission ID- 39769) (Irrigation Purpose)**

The application has been processed. However, since the Himachal Pradesh Ground Water (Regulation and Control of Development and Management) Amendment Act, 2022 has come into force in the State of HP w.e.f 28.03.2023 vide Govt. Notification dated 27.03.2023 & following categories under section 2 (o) of the said Act have been exempted from seeking permit for drilling of new borewell:

However, since the Himachal Pradesh Ground Water (Regulation and Control of Development and Management) Amendment Act, 2022 has come into force in the State of HP w.e.f 28.03.2023 vide Govt. Notification dated 27.03.2023 & following categories under section 2 (o) of the said Act have been exempted from seeking permit for drilling of new borewell:

- 1) Individual Domestic Consumer
- 2) Rural Drinking Water Supply Scheme
- 3) Armed Forces and Central Armed Police Establishments
- 4) Agricultural Activities

**14. CMG Biotech Private Limited Plot No - 53,54 Phase - I, Industrial Area, Sansarpur Terrace (Submission ID- 38346)**

The applicant has applied on **Form – 1A** for grant of permit for sinking of borewell for **Industrial Purpose**. As per the report of Sr. Hydrogeologist, G.W.O., JSV, Una, **No departmental energized borewell exists within a distance of around 300m from the proposed borewell of the applicant. The site is located on a river terrace and comprises of alluvial deposits comprising of clays, gravels, pebbles, boulders & sand underlain by boulder conglomerates of Shiwalik group of rocks.**

The application was forwarded to the Senior Hydrogeologist & Executive Engineer concerned for site inspection/verification as per uploaded documents and for floating the public notice {Form-2 rule 17 (1) / Form-5 rule 23 (1)} in the offices of concerned Gram Panchayat or Urban Local Authority having jurisdiction, Executive Engineer, Assistant Engineer and Junior Engineer and in case of Industrial/commercial use also for Publication in two leading newspapers, so that interested persons, if any, may file their objection/suggestions. No objection has been received.

Hence, the sub-committee approved the case subject to the following conditions:

- i) The applicant shall construct a rainwater harvesting structure for the conservation and re-charge of ground water in his/her/their premise as per section-15 of the Himachal Pradesh Ground Water (Regulation & Control of Development and Management) Amendment Act, 2022 and Guidelines to regulate and Control ground water extraction in the State of Himachal Pradesh vide Notification No. IPH-B (A) 3-1/2019-II dated 03.05.2021, within six months of issuance of the Certificate of Permit and intimation will be given to Executive Engineer, JSV Division Pragpur on its completion.
- ii) The applicant shall install a water meter/bulk meter on the ground water extraction pipe so as to check the water drawl at any time and will maintain its log book.
- iii) The applicant shall have to pay royalty based on the quantum of ground water extraction through Executive Engineer, JSV Division Pragpur for the use of ground water to the Member Secretary, Himachal Pradesh Ground Water Authority as per the Himachal Pradesh ground Water (Regulation and Control of development and Management) Rules, 2007 or the rules which may, subsequently, be made applicable by the State of HP.
- iv) In case of Industrial connection, the firm shall not use waste water of the Industry for recharging of ground Water.
- v) That the permission/sanction can be withdrawn or the quantity of water to be extracted can be restricted in case the ground water in the area is adversely affected in terms of quantity and/or quality.
- vi) Actual water requirement be computed taking into account recycling/reuse of treated water for flushing etc.
- vii) Certificate regarding non/partial availability of water supply from the public water supply agency.
- viii) The firm/applicant shall be required to adopt latest water efficient technologies so as to reduce dependence on ground water resources.
- ix) The firm/applicant drawing water more than 10m<sup>3</sup> /day of ground water shall construct piezometer, equipped with DWLR of latest version within six months shall consultation with the Sr. Hydrogeologist, GWO, JSV, Una (HP) and monthly water level date shall be submitted to the Ground Water Organization and Himachal Pradesh Ground Water Authority.

- x) All stakeholders abstracting ground water in excess of 100 m<sup>3</sup>/d shall be required to undertake annual water audit through Confederation of India Industries (CII)/Federation Indian Chamber of Commerce and Industry (FICCI)/National Productivity Council (NPC) certified auditors and submit audit reports within three months of completion of the same to Himachal Pradesh Ground Water Authority. All such stakeholders shall be required to reduce their ground water use by at least 20% over the next three years through appropriate means
- xi) The holder of the Permit shall be duly bound to maintain the aforementioned source in an efficient, coordinated and economical manner and to use the water only for the purpose for which certificate of registration has been given.
- xii) The supporting document in r/o water requirement mentioned at the time of registration with Industry Department.

Therefore, as per the unanimous decision taken by the Sub-Committee, the concerned Executive Engineer (Pragpur) is directed to convey the decision of Sub-Committee to the firm/applicant.

Hence, the sub-committee approved the case subject to the following conditions:

- i) The applicant shall construct a rainwater harvesting structure for the conservation and re-charge of ground water in his/her/their premise as per section-15 of the Himachal Pradesh Ground Water (Regulation & Control of Development and Management) Amendment Act, 2022 and Guidelines to regulate and Control ground water extraction in the State of Himachal Pradesh vide Notification No. IPH-B (A) 3-1/2019-II dated 03.05.2021, within six months of issuance of the Certificate of Permit and intimation will be given to Executive Engineer, JSV Division Solan on its completion.
- ii) The applicant shall install a water meter/bulk meter on the ground water extraction pipe so as to check the water drawl at any time and will maintain its log book.
- iii) The applicant shall have to pay royalty based on the quantum of ground water extraction through Executive Engineer, JSV Division Solan for the use of ground water to the Member Secretary, Himachal Pradesh Ground Water Authority as per the Himachal Pradesh ground Water (Regulation and Control of development and Management) Rules, 2007 or the rules which may, subsequently, be made applicable by the State of HP.
- iv) In case of Industrial connection, the firm shall not use waste water of the Industry for recharging of ground Water.
