ENGAGEMENT NOTICE

In continuation to this office advertisement No. 29714-20 dated 24.01.2024 (Classified) applications which were invited for filling up 40 Nos. Posts of various categories i.e 11 nos. post of Para Pump Operator, 04 nos. post of Para Fitter and 25 nos. post of Multipurpose Workers from desirous Bonafide Himachali candidates on prescribed Proforma and also further as per clarification received from the O/o the Engineer-in-Chief vide letter No. JSV-ES-III-D.W.Manpower-Vol.-VI/2022-416-495 dated 26.04.2024 w.r.t reservation of posts for Scheduled Caste, Other Backward Classes, Schedule Tribe categories and E.W.S categories, the applications are once again invited for filling up the available posts under Jal Shakti Division Dharamshala as per the reservation roster.

Candidates who have applied against earlier advertisement No. 29714-20 dated 24.01.2024 (Classified) need not apply again however they are required to submit the required documents of SC/ST/OBC/EWS category and latest EWS category certificate if they wish to get the benefit of reservation under SC/ST/OBC/EWS category. The latest BPL certificate is required from the applicants, who have already applied/submitted the application to this office for the post of Para Pump Operator and Para Fitter only.

The candidates who belongs to schemes caste, Other backward classes, economically weaker section and Schedule tribe category may submit their category certificate ((SC/ST/OBC/EWS) duly signed by the competent authority.
3	Multi Purpose Worker	25	U.R:- 13 S.C:- 05 O.B.C:- 04 E.W.S:- 02 S.T:- 01	The candidates should have a minimum qualification of Middle Pass (8 th) and its equivalent form school duly recognized by the State Government. The candidates who belongs to schedule Caste, Other backward classes, economically weaker section and Schedule Tribe may submit their category certificate (SC/ST/OBC/EWS) duly signed by the competent authority. All candidates must ensure to submit their 8 th standard mark sheet.

Note:- Candidate applying for Multipurpose workers shall compulsory attached detailed marks sheet of middle standard and in the event of non issuing of the same by the concerned Education Board the detailed marks certificate from the Principal of the school needs to be attached. Evaluation criteria and short listing (if necessary) is based upon marks obtained in the Middle standard and not of any other standard even if higher qualification is obtained.

Age Limit:- 18 to 45 Years.

The number of posts may increase or decrease depending upon Vacancy position as per the requirement of Jal Shakti Vibhag.

The selected candidates can be posted anywhere under the jurisdiction of this Division.

Documents to be attached with application form:-

Attested/self-attested copies of (i) Legitimate proof of age (ii) Proof of BPL Family in case BPL candidate issued not later than six months (iii) Proof of Educational and Technical qualification (iv) Certificate of Bonafide of Himachal Pradesh (v) Certificate of experience (if any) in the related field of JSV/HPPWD/CPWD/PSUs/outsourcing agency providing services in H.P issued by the competent authority not older than six months (VI) Category certificate SC/ST (VII) EWS category certificate issue by the competent authority not be older than six months.
