A clarification has been received from the Engineer-in-Chief Jal Shakti Vibhag Shimla-5 office letter No. JSV-ES-III-D.W-Manpower-Vol-VI/2022-416-495 dated 26.04.2024, regarding reservation of posts for Scheduled Caste, Scheduled Tribe, Economic Weaker Section(EWS) and Other Backward Class categories. - IX) If a candidate applies from the EWS category then it is necessary(Income certificate issued not older than 6 months.)

- III) Proof of age i.e. date of birth certificate
