In continuation to this office advertisement No.29708-12 dated 29.01.2024 (Classified) applications from desirous Bona-fide Himachali candidates on prescribed Performa which were invited for filling up 40 Nos. posts of various categories i.e 11 nos. of Para Pump Operator, 04 nos. of Para Fitter and 25 nos. of Multipurpose Workers and also as per clarification received from the O/o the Engineer-In-Chief vide letter No. JSV-ES-III-D.W. Manpower- Vol.-VI/2022-416-495 dated 26.04.2024 w.r.t reservation of posts for Schedule Caste, Other Backward Classes, Schedule Tribe categories and E.W.S categories, the applications are once again invited for filling up the available posts under Jal Shakti Division Barsar.

❖ **Candidates who have applied against earlier advertisement No. 29708-12 dated 29.01.2024 (Classified) need not apply again however they are required to submit the required documents of SC/ST/OBC/EWS category and latest EWS category certificate if they wish to get the benefit of reservation under SC/ST/OBC/EWS category. The latest BPL certificate is required from the applicants, who have already applied /submitted the application to this office for the post of Para Pump Operator and Para fitter only.**

Multi Purpose Worker.	25	U.R.- 13 S.C.- 04 O.B.C.- 03 E.W.S.- 03 S.T.- 02	The candidate should have a minimum qualification of Middle pass (8 <sup>th</sup> ) and its equivalent from school duly recognized by the State Government. The candidates who belongs to schedule caste, other backward classes, economically weaker section and Schedule tribe may submit their category certificate (SC/ST/OBC/EWS) duly signed by the competent authority. All candidates must ensure to submit their 8 <sup>th</sup> standard mark sheet.

**Note:-** Candidate applying for Multipurpose workers shall compulsory attached detailed marks sheet of middle standard and in the event of non issuing of the same by the concerned Education Board the detailed marks certificate from the principal of the school needs to be attached . Evaluation criteria and short listing (if necessary) is based upon marks obtained in the Middle standard and not of any other standard even if higher qualification is obtained.

**Age Limit:-** 18 to 45 Years.

The number of posts may increase or decrease depending upon Vacancy position as per the requirement of Jal Shakti Vibhag.

The selected candidates can be posted at anywhere under the jurisdiction of this Division.
