Manpower- Vol.-VI/2022-416-495 dated 26.04.2024 with reference to reservation of posts for Scheduled Caste, Other Backward Classes, Schedule Tribe categories and E.W.S categories, the applications are once again invited for filling up the available posts under Jal Shakti Division Amb, Distt. - Note:- Candidate applying for Multipurpose workers shall compulsory attached detailed marks sheet of middle standard and in the event of non issuing of the same by the concerned Education Board the detailed marks certificate from the principal of the school needs to be attached . Evaluation criteria and short listing (if necessary) is based upon marks obtained in the Middle standard and not of any other standard even if higher qualification is obtained.
