Schedule of Meeting with State Governments for the finalization of Annual Action Plan (AAP) for 2013-14 for NRDWP and Annual Implementation Plan for 2013-14 for NBA.

Please find enclosed here with copy of G.O.I. D.O. letter No. 14018/52 (AAP)/2012-DWS (Stat) dated 14.01.2013 received from Director,(W) Ministry of Drinking Water & Sanitation RGNDWM, G.O. vide which draft annual action plan for the year 2013-14 has been desired on the prescribed formats 1-18 (available on G.O.I. website.)

It is tentatively proposed to cover 2500Habitations with safe drinking water facility during 2013-14 i.e. 1250 habitations under NRDWP and 1250 habitations under MNP. District wise tentative targets will be as under

It is therefore requested to prepare Division wise/ Scheme wise action plan for coverage of Habitations depicting population against each habitation with respect to your Zone on the prescribed formats available on G.O. website. The district wise tentative target proposed under different sector of habitations is also enclosed for ready reference. While finalizing the target the following issues/ points should be given due consideration.

- (i) On going Schemes should be taken up for completion in the 1st instance.
- (ii) Among the ongoing and new schemes:
- 1 **Ist Priority** should be given to **0-25** % population covered habitations
- 2. 2Nd priority be given for coverage to those habitations having population coverage >25% &<50%, than >50% &<75% and in the last>75% &<100% population covered habitations.
- Among Quality affected habitations those affected with contamination of source by arsenic, fluoride, nitrate, salinity & iron should be given highest priority.
- To ensure the availability of drinking water on sustainability basis in SC/ST concentrated habitations in the state, it is required to earmark at least 22% of the NRDWP funds for drinking water supply to the SC dominated habitations and another minimum 10% for ST concentrated habitations. In case where the state has achieved full coverage of SC/ST habitations work may be taken up for augmentation scheme in the SC/ST habitations to raise service level. Where the %age of SC or ST population in a particular State or the existing coverage of SC/ST concentrated habitations warrants earmarking/ utilization of more than stipulated provision, addition funds can be utilized. The district wise list of SC concentrated targeted habitations be prepared at Zonal level so that

same can be supplied to Department of Social Justice & Empowerment to include the same under SCSP, demand No 32 in the Budget book.

- 5. Where ever required and feasible, ongoing and new schemes should have component of sustainability which may include rain water harvesting and ground water recharging structure to be taken-up 10% under sustainability,15% for O&M,5% for Support activities & 3% for Water Quality Monitoring & Surveillance of the state allocation is earmarked under NRDWP funds
- Since the State Annual Action Plan 2013-14 for NRDWP is to be sent to DDWS by 31st January ,2013, the online entries may be completed by 30th January,2013.

The copy of G.O.I. D.O letter W-11014/02/2010-NRDWP dated 3rd January,2013 along with 18 formats is being e-mailed to you for preparation of Annual Action Plan 2013-14 immediately and early submission of the same to this office through e-mail /hard copy.
