**NOTIFICATION**

The Governor, Himachal Pradesh in partial modification of this Department notification No. IPH-B© 17-4/2008-I dated 29-10-2013 and on recommendations of the State Technical Committee of Jal Shakti Vibhag, Himachal Pradesh is pleased to amend the Rules of Enlistment of Contractors in Jal Shakti Vibhag, 2013 as under :-

1.	<b>Rule- 4 Applicability</b>	<b>Sub rule 4.4 under Rule 4 is amended as under:-</b> A contractor is not permitted to have enlistment in more than one name. However, in case of a Company/ Firm, a Director/Partner can be permitted to get enlisted as an individual subject to the condition that firm issues NOC to the individual and he shall not be allowed to participate in the tender where present firm is participating.

	<b>Rule- 26 Jurisdiction</b>	The entire dispute regarding these rules shall be subject to the jurisdiction of courts within the territory of Enlistment authority.
